INDUSTRIAL DISPUTES - DECEMBER QUARTER, 1963

This bulletin, the first of a series to be issued quarterly, contains statistics of industrial disputes, involving a stoppage of work of ten man-days or more, for the quarter ended 31st December, 1963, and for the twelve months ended 31st December, 1963.

In addition to details of disputes in industry groups for each State and Australia, statistics of Causes, Duration and Methods of Settlement for the year 1963 are given in Tables 4 to 6.

Detailed statistics of industrial disputes to March quarter 1963 were published in issues of the "Monthly Bulletin of Employment Statistics". Similar figures for the June and September quarters, 1963 are available on request.
