WHOLESALE PRICE (BASIC MATERIALS AND FOODSTUFFS) INDEX, JULY 1969

This bulletin contains particulars of selected groups and "All Groups" of the Wholesale Price (Basic Materials and Foodstuffs) Index from 1936-37 to the present time.

2. The weighting system used in this index is based on estimates of the average annual consumption of included commodities in Australia from 1928-29 to 1934-35. The validity of the weighting and the representativeness of the index have become increasingly affected by changes in usage and in industrial structure. New series of wholesale price index numbers relating to materials used and articles produced by defined areas of the economy are being developed. The first of these indexes, the Wholesale Price Index of Materials used in Building other than House Building (Ref. No. 9.6), was issued on 23 April 1969. Work continues on the preparation of two further measures, relating to materials used in house building and in manufacturing industry respectively. Taken together, these first three series will, to a considerable extent, constitute a currently representative replacement for the Wholesale Price (Basic Materials and Foodstuffs) Index, which in the meantime will continue to be published in the form shown in this bulletin. This is to meet the needs of those who, for special purposes, require the particular indexes included. However, it should be noted that the Building Materials group has been largely superseded by the Wholesale Price Index of Materials used in Building other than House Building, referred to above.
3. A list of the commodities and other information concerning the Wholesale Price (Basic Materials and Foodstuffs) Index is set out in Labour Report No. 52, 1965 and 1966.
4. Commodities in the index are priced in their primary or basic form wherever possible and as nearly as may be at the point where they first make effective impact on the Australian price structure. The prices of imported goods, for instance, are on an ex-bond or into factory basis.
5. The prices used have, in the main, been obtained directly from manufacturers and merchants. With a few important exceptions, they are from Melbourne sources.
6. The index is constructed on the aggregative fixed weights formula.
