Introduction

1. This bulletin contains details of the lending operations of finance companies compiled from monthly returns collected from those companies. Information on the scope of these statistics up to June 1974 and definitions of items are contained in the annual bulletin *Finance Company Transactions 1973-74* (Reference No. 5.13) which provides more detailed statistics.

Presentation

2. Figures for each State are compiled on the basis of business written or recorded by finance companies (or branches of finance companies) operating in that State, but this does not necessarily indicate that the funds so provided are for use within that State. The extent to which funds may be raised in one State for use in another is not known.

3. Tables 1 to 6 show details of the transactions of finance companies other than leasing, bills of exchange, loans to related non-finance companies and liquidity placements. These latter transactions are covered in Table 7.

4. Table 8 provides certain details on the operations of Selected Finance Companies which may be regarded as "merchant banks" falling within the scope of the Finance Companies collection. A detailed statement of the criteria used to select finance companies for inclusion in Table 8 is contained in the annual bulletin *Finance Company Transactions 1973-74* (Reference No. 5.13).

5. A further dissection of "amount financed" by purpose of loan for instalment credit for retail sales provided by finance companies is given in the monthly bulletin *Instalment Credit for Retail Sales* (Reference No. 5.46).

Revisions

6. This bulletin incorporates revisions made to previous statistics in this series.
