BUILDING APPROVALS : AUSTRALIA, DECEMBER 1967

Statistics of building approvals have been compiled from (a) permits issued by local government authorities in the areas subject to building control by these authorities and (b) contracts let or work commenced and day labour projects authorised by government authorities. They relate only to approvals for building, as distinct from the construction of roads, bridges, railways, earthworks, water storage, etc.

Values shown represent the estimated cost when completed (excluding cost of land) of new buildings and alterations and additions to existing building.

Prior to 1 July 1966 additions of \$10,000 and over are included with new buildings in all States except New South Wales where they are included in "alterations and additions". From 1 July 1966 alterations and/or additions of \$10,000 and over are included with new buildings in all States. A line drawn across the column between two consecutive figures shows a break in continuity of series.

Building is classified as "Private" or "Government" according to ownership.

For purposes of comparison, it should be borne in mind that the volume of building approvals is affected from month to month by the number of large projects, such as blocks of flats and multi-storey office buildings, approved in particular months and also by the administrative arrangements of local government and semi-governmental authorities.

- (a) In the seasonal adjustment, account has been taken not only of normal seasonal factors but additionally of "trading-day" effects (arising from the varying numbers of Sundays, Mondays, Tuesdays, etc. in the month) and the influence of Easter which may, in successive years, affect figures for different months. Details of the methods used in seasonally adjusting these and other series are given in the annual bulletin, "Seasonally Adjusted Indicators, 1967", together with figures for earlier periods. All seasonally adjusted figures are subject to revision.
