MAIN FEATURES

Credit co-operatives with assets in Australia exceeding \$5 million

Deposits and share capital at the end of November 1986 totalled \$5,995.0 million, up slightly on the October 1986 figure of \$5,954.1 million.

Loans advanced and book debts purchased during November 1986 totalled \$231.9 million, a decrease of \$10.1 million (4.2%) on October 1986 and \$20.1 million (8.0%) on November 1985.

General financiers with assets in Australia exceeding \$5 million

Total assets at the end of November 1986 were \$6,945.4 million, an increase of \$613.7 million (9.7%) on October 1986.

EXPLANATORY NOTES

Introduction

This publication is compiled from statements furnished under the *Financial Corporations Act 1974* from corporations registered under the Act and categorised as:

- (a) credit co-operatives;
- (b) pastoral finance companies;
- (c) general financiers;
- (d) retailers;
- (e) intra group financiers; and
- (f) other financial corporations.

Depending on the category of the corporation, it presents statistics on financial operations, assets, selected liabilities and interest rates.

2. Details of the scope and coverage of these statistics are provided in the July 1986 issue of this publication.

3. The population for the various categories may vary from month to month due to:

- (a) registration of corporations;

(b) change in category; and

(c) deletion of corporations no longer registrable.

Particular care should therefore be taken in interpreting individual month-to-month movements.

Presentation

4. Tables 1 and 2 continue the monthly series for credit co-operatives with assets in Australia exceeding \$5 million which commenced in July 1976 and the series are now presented on a State basis as from May 1984. Table 3 presents maturity dissection of borrowings by State as from June 1984. Table 4 continues the monthly series on interest rates by State which commenced in June 1984. Table 5 continues the quarterly series for credit co-operatives with assets in Australia not exceeding \$5 million which commenced in September 1976 and the series are now presented on a State basis as from June 1984.

5. Tables 6 to 8 continue the monthly series for general financiers with assets in Australia exceeding \$5 million which commenced in July 1976. Tables 9 and 10 present maturity dissection of borrowings and selected assets as from June 1984. Table 11 continues the monthly series on interest rates which commenced in June 1984. Tables 12 and 13 continue the quarterly series for general financiers with assets in Australia not exceeding \$5 million which commenced in September 1976.

6. Tables 14 and 15 continue the monthly series for pastoral finance companies which commenced in July 1976. Prior to June 1984, all the series in Tables 14 and 15 exclude pastoral finance companies with assets in Australia not exceeding \$5 million. Tables 16 and 17 present maturity dissection of borrowings and selected assets as from June 1984. Table 18 continues the quarterly series on interest rates which commenced in June 1984. Details of selected liabilities and assets (by quarter) for pastoral finance companies with assets in Australia not exceeding \$5 million are contained in the publication *Financial Corporations Statistics, Australia* (\$617.0) of which the final issue was for May 1984.

7. Tables 19 to 21 present, on a quarterly basis, a series for intra group financiers and other financial corporations. This replaces a monthly series previously presented up to June 1984 for these types of corporations with assets exceeding \$5 million, and a quarterly series previously presented up to the June quarter 1984 for these types of corporations with assets in Australia not exceeding \$5 million.

8. Table 22 presents, on a six-monthly basis, a series for retailers. This replaces a quarterly series which commenced in September 1977 and ceased in June 1984.

Data items

9. Data items are reported in accordance with the directions contained in the Schedule to the Financial Corporations (Statistics) Regulations. It should be noted that, unless otherwise specified in the directions, corporations have been requested to value their assets and liabilities on the basis used in their latest audited accounts.

Statistical period

10. While the statistics are described as being for a statistical period (month/quarter/half year) it should be noted that some corporations have accounting periods which do not correspond exactly to the statistical period and their figures are used without adjustment.

Comparability

11. Because of differences in size and classification criteria, the statistics in this publication are not directly comparable with statistics for credit co-operative/unions in the publication *Credit Unions, Assets, Liabilities, Income and Expenditure, Australia* (5618.0).

Revisions

12. This publication incorporates revisions made to statistics for previous periods.
