EXPLANATORY NOTES

Introduction

This publication is issued each month as a supplement to the annual *Catalogue of Publications and Products, Australia* (1101.0) of the Australian Bureau of Statistics, which lists current ABS publications and gives brief descriptions (abstracts) of their contents. In addition, a *Publications Advice* (1105.0) is issued each Tuesday and Friday listing publications released on the day of issue and expected releases on the following five days (national publications) or two days (State/Territory publications).

2. A brief description of the contents of new publications, changes to existing publications and other information of interest appears at the back of this publication.

Publication prices

3. Prices include postage both within Australia and overseas (economy air).

Mailing service

4. Clients who wish to receive publications on a regular basis may use the ABS Publications Subscription Service. For further details please refer to the back page of this publication.

5. Clients who already use this service and who wish to change their requirements should quote their client identification number when contacting ABS. The number is shown at the top left hand corner of the address label used to despatch publications to clients.

6. Renewal notices are sent to all subscribers annually in respect of the subscription year commencing on 1 January. Payment for priced publications is required in advance and should accompany renewal notices returned to ABS.

Statistical information service

7. Each ABS office has an information Consultancy service to assist clients by providing a first point of entry to the ABS. Information consultants will assist where possible or, where appropriate, refer the enquiry to a contact officer. The Information Consultancy area offers a limited free service providing information from published statistics both over the telephone and over the counter at ABS bookshops. The area also offers a fee for service information consultancy for detailed queries or provision of information from the ABS's vast unpublished data holdings. Unpublished statistics cover a variety of topics such as small area population information, imports and exports, building, tourism and detailed Consumer Price Index information, to name just a few. The area offers various dissemination options from paper reports to floppy disks and magnetic tape.

8. In cases where a considerable volume of data has to be specially extracted or where a regular statistical service is required, a charge will be made.

ABS PUBLISHING NEWS

New Publications Released During May 1993

- 1292.0 *Australian and New Zealand Standard Industrial Classification (ANZSIC), 1993* (\$75.00)

The ANZSIC is to be implemented for all ABS industry classified statistics and is a fundamentally important reference for organisations to interpret these statistics or to compile their own statistics on a comparable basis. The ANZSIC is also to be implemented by the New Zealand Department of Statistics with whom it was jointly developed. This publication presents the detailed classification and defines each industry class identified in it. It also includes concordances with the ASIC, the New Zealand Standard Industrial Classification and the International Standard Industrial Classification of Economic Activities.

- 1298.0 *Information Paper: Australian and New Zealand Standard Industrial Classification (ANZSIC), 1993*

This paper describes the review of the Australian Standard Industrial Classification and the changes made with the introduction of the ANZSIC. It outlines ABS plans for implementation of the ANZSIC in its published statistics and the range of ANZSIC products and services that will be available.

- 1322.0 *Profiles of Australian Business, 1992* (\$21.00)

Contains statistical information extracted from the ABS Business Register. The prime purpose of this Register is to provide a framework for the selection of businesses for ABS economic censuses and surveys but it is also used as a source of counts of businesses by type of industry activity and location. Coverage of the Register is those businesses in Australia, private and public sector, that have employees. The publication tables display summary counts for both business units and locations cross-classified by State, public/private sector, industry and employment size. More detailed information is available on request.

- 2909.0 *1991 Census — Urban Centres/Localities Code List* (\$10.00)

Lists the names and codes of the Urban centres and Localities defined for the 1991 Census.

- 2730.4 *1991 Census — Census Counts for Small Areas, South Australia* (\$25.00)

Contains counts of persons and dwellings at local government area, statistical local area, statistical division and urban centre/locality levels, with a time series comparing 1986 and 1991 Census counts where possible. Publications include maps showing statistical division and statistical local area boundaries. There are separate publications for each State/Territory.

- 4113.0 *Women in Australia, 1993* (\$30.00)

A comprehensive statistical report addressing issues of specific concern to women in Australia. Subjects covered include family, health, education, paid and unpaid work, income and expenditure, housing, crime and justice and leisure.

New Publications Released During May 1993—continued

4123.5 *Western Australia's Young People, 1991* (\$12.50)

This publication, produced jointly with the National Youth Affairs Research Scheme, provides a range of statistics on Western Australia's young people. Compiled mainly from 1991 Census data, the profile includes sections on population, cultural diversity, living arrangements, education, working life and income.

5242.0 *Australian National Accounts: State Accounts, 1992* (\$21.40)

Detailed presentation of quarterly State accounts for the last nine quarters, at both current and, in some cases, at average 1989-90 prices, original and, for some series, seasonally adjusted. Estimates are provided by State and Territory for income-based gross State product; wages, salaries and supplements; gross operating surplus; indirect taxes less subsidies; domestic final demand; private final consumption expenditure; government final consumption expenditure; private gross fixed capital expenditure; and public gross fixed capital expenditure. Historical data are also provided from September quarter 1984.
