This publication contains a comprehensive description of the Australian C.P.I.; what the index measures; the goods and services included in it; where the information on prices comes from; and how the index is compiled. It also attempts to provide some insights into the kinds of problems encountered in compiling the C.P.I. and how these are dealt with.

ABS OCCASIONAL PAPER 1984/2 - POSTCENSAL INTERSTATE MIGRATION ESTIMATES, 1966-1981

The paper discusses the sources and limitations of interstate migration data in Australia and evaluates the quality of derived estimates of postcensal interstate migration for the period 1966-81. It also describes the methods used since 1981 to obtain interstate migration estimates.
