EXPLANATORY NOTES

Introduction

This publication is issued each month as a supplement to the annual *Catalogue of Publications, Australia* (1101.0) of the Australian Bureau of Statistics, which lists current ABS publications and gives brief descriptions (abstracts) of their contents. In addition, a *Publications Advice* (1105.0) is issued each Tuesday and Friday listing publications released on the day of issue and expected releases on the following five days (Canberra Office) or two days (State Offices).

2. Significant occurrences in ABS Publishing are highlighted in the section Publishing News which follows the list of publications issued during the month. Publishing News contains brief descriptions of the contents of new publications, describes changes in ABS publications and shows other information of interest to users of ABS publications.

Publication prices

3. Two prices are shown for each priced publication. The first price given is the 'over the counter' price while the second includes packaging and postage at ordinary rates within Australia. Overseas clients should add 10 per cent of the second price to meet the cost of overseas surface postage. Airmail rates are available on request.

4. Where no price is shown the publication is free.

Mailing list service

5. Clients who wish to receive free or priced publications on a regular basis may use the ABS computerised Publications Mailing List (PML) Service. Further details and order forms are available from any ABS office.

6. Clients (or subscribers) who already use the PML Service and who wish to amend their requirements should quote their account number when contacting ABS. The account number is shown at the top left hand corner of the address label used to despatch publications to clients.

7. Renewal notices are sent to all subscribers annually in respect of the subscription year commencing on 1 January. Payment for priced publications is required in advance and should accompany renewal notices returned to ABS.

Statistical information service

8. Each ABS office has an Information Service to assist clients. The service is designed to answer inquiries from clients on available official statistics, including statistics not published for economic reasons. Unpublished statistics cover a variety of topics such as population, dwellings, building, imports, exports, shipping, etc., in the form of computer printout, microfiche, magnetic tape or specially prepared tables.

9. In cases where a considerable volume of data has to be specially extracted or where a regular statistical service is required, a charge may be made.

ABS PUBLISHING NEWSNew Publications released during November 1985

- 5334.0 Foreign Ownership and Control of Registered Financial Corporations,
Australia, 1984
Irregular; 24pp

This publication contains details on assets and selected liabilities of corporations registered under Financial Corporations Act 1974. Statistics show assets and selected liabilities apportioned to ownership, by type and country of ownership and category of corporation and allocated to control by country of control, degree of influence of major foreign investor and size and type of corporation.

- 5643.0 Commercial Finance, Australia, January to March 1985
Monthly; 14pp

This publication presents statistics of commercial finance commitments made by significant lenders to government, private and public enterprises, and non-profit organisations as well as to individuals (for investment and business purposes) during the period January to March 1985. Lease finance commitments are excluded from the publication. They are included in Lease Finance, Australia (5644.0).

- 1115.1 Information Paper : Population Surveys, 1960 to 1985
Irregular; 18pp

This information paper lists the topics of all monthly supplementary surveys and special supplementary surveys conducted from 1960 to 1985 by the Australian Bureau of Statistics as part of the population surveys program. It also lists catalogue numbers of publications which detail the final results of these surveys or, where not yet published, the catalogue numbers of the publications expected to contain the final results of the surveys.

- 6235.1 Labour Force Status and Educational Attainment, New South Wales, February 1985
Irregular; 24 pp

This publication contains details of a survey conducted in February 1985 on the educational attainment of persons aged fifteen and over for New South Wales and for regions of the state.

- 4111.2 Youth in Victoria, 1985
Irregular; 88pp; \$4.00, \$4.80

This publication is a social report in three parts focusing on youth in Victoria aged 15-24 years. Chapter 1 includes a brief demographic profile of youth, their living environment, health, income and the incidence of crime. Chapter 2 discusses educational participation and the transition from education to work. The final chapter provides data on the labour force participation of youth, including details of the unemployment and youth not in the labour force.

4220.2 National Schools Statistics Collection, Victoria, 1985, Preliminary Annual; 22pp

This publication contains preliminary statistics of government and non-government schools and full-time students enrolled and active in a course of study at those schools at July 1985.

4221.2 National Schools Statistics Collection, Victoria, 1984 Annual; 24pp

This publication contains statistics of primary and secondary education compiled using the concepts of the National Schools Statistics Collection.

7222.5 Poultry Slaughtered, Western Australia, October 1985 Monthly; 2pp

This publication contains details on the number of poultry and value of live birds slaughtered for human consumption, and the dressed weight of meat produced from meat chickens and all other poultry comprising other chickens, ducks and turkeys.

1202.4 Information Paper: Guidelines for the Development of Community Surveys, South Australia, 1985 Irregular; 10pp

This paper is designed to promote understanding of complexities involved in developing and conducting community based sample surveys. It identifies a range of important issues, including the definition of objectives, determination of sample size, collection and processing methods, sources of error, presentation and assessment of results, and sources of further assistance.

4221.4 National Schools Statistics Collection, South Australia, 1984 Annual; 12pp

This publication contains statistics of primary and secondary education compiled using the concepts of the National Schools Statistics Collection.

7323.6 Apples and Pears in Cool Stores, Tasmania, September 1985 Monthly; 1pp

This publication contains details of quantities of apples and pears held in cool stores by month, by fruit variety and storage method.

. New Fixed Capital Expenditure by Private Enterprises in Selected Industries, Australia, June Quarter 1985 (Actual) July to December 1985 (Expected) January to June 1986 (Expected) (5626.0), released on 13 November 1985, noted that revisions to June quarter 1985 preliminary estimates and previous quarters' data have resulted from:

. the need to estimate for non-response at the time the preliminary estimate was compiled; and

. a reassessment of the growth in new businesses over the 1984-85 financial year.

. Commercial Finance, Australia, January to March 1985 (5643.0), released on 13 November 1985, announced that commercial finance commitments under fixed loan facilities were understated to a small extent due to the inability of some banks to separate, from their personal lending commitments, amounts relating to lending to individuals for business or investment purposes. The ABS is taking action to overcome this problem.

. Price Indexes of Metallic Materials, Australia, October 1985 (6410.0), released on 20 November 1985, announced that the ABS is currently preparing a new and expanded set of price indexes relating to materials and fuels used in Australian manufacturing industries. The new indexes will become available during the first half of 1986 and will contain index numbers back to July 1985 on a reference base: Year 1984-85 = 100.0.

Among the new price indexes, which will be published in 'Price Indexes of Materials Used in Manufacturing Industry' (6411.0), will be index numbers for certain metallic materials which will replace the series presently published in Table 1 of 'Price Indexes of Metallic Materials, Australia' (6410.0). The existing series of index numbers on reference base: Year 1968-69 = 100.0 will be replaced by index numbers from the new series from July 1985 onward.

. Price Index of Materials Used in Manufacturing Industry, Australia, August 1985 (6411.0), released on 4 November 1985, announced that significant revisions have been made to previously published index numbers for the six months to June 1985 and the financial year 1984-85 for the following series: Table 2: Imported materials - mining; Total imported materials; All groups; Table 3: Electricity, gas and fuels: All groups.
