BROKERS AND DEALERS RECEIVALS OF TAXABLE WOOL JULY 1977

This bulletin contains details of the amount of taxable wool received by brokers and dealers from wool producers. It excludes wool received by brokers on which tax has already been paid by other dealers (private buyers) or brokers.

The information shown below is on the basis of the State in which the wool has actually been received and does not necessarily reflect the production of wool in that State.
