PRODUCTION SUMMARY NO. 47
AERATED AND CARBONATED WATERS (a) : CORDIALS AND SYRUPS
AUSTRALIA : DECEMBER 1973

The monthly totals of production of smaller establishments in New South Wales and Queensland have been estimated from the returns of a representative sample. This sample is designed to provide reliable estimates of total production in these States. In addition, as the degree of estimation in Capital City statistical divisions is negligible, figures for production of aerated waters in each Capital City statistical division are separately compiled and published herein. It follows that any sample error for these States will be chiefly contained in that part of the State total which is attributable to country production. Therefore the deduction of Capital City statistical division figures from the totals will not give completely reliable figures for country areas in New South Wales and Queensland.

The figures for 1971-72 are derived from the Annual Factory Census. All other annual figures are derived from the recorded monthly production and are subject to revision. Production figures for Northern Territory are included with South Australia.
