EXPLANATORY NOTES

Introduction

1. This publication is issued each month as a supplement to the annual *Catalogue of Publications, Australia* (1101.0) of the Australian Bureau of Statistics, which lists current ABS publications and gives brief descriptions (abstracts) of their contents. In addition, a *Publications Advice* (1105.0) is issued each Tuesday and Friday listing publications released on the day of issue and expected releases on the following five days (Canberra Office) or two days (State Offices).

2. Publishing News contains brief descriptions of the contents of new publications, describes changes in ABS publications and shows other information of interest to users of ABS publications.

Publication prices

3. A single price now applies to publications despatched by surface mail both within Australia and overseas, and to counter sales. Airmail rates are available on request.

Mailing service

4. Clients who wish to receive publications on a regular basis may use the ABS computerised Publications Mailing Service. Further details and order forms are available from any ABS office.

5. Clients who already use this service and who wish to amend their requirements should quote their account number when contacting ABS. The account number is shown at the top left hand corner of the address label used to despatch publications to clients.

6. Renewal notices are sent to all subscribers annually in respect of the subscription year commencing on 1 January. Payment for publications is required in advance and should accompany renewal notices returned to ABS.

Statistical information service

7. Each ABS office has an Information Service to assist clients. The service is designed to answer inquiries from clients on available official statistics, including statistics not published for economic reasons. Unpublished statistics cover a variety of topics such as population, dwellings, building, imports, exports, shipping, etc., in the form of computer printout, microfiche, magnetic tape, floppy disk or specially prepared tables.

8. In cases where a considerable volume of data has to be specially extracted or where a regular statistical service is required, a charge will be made.

ABS PUBLISHING NEWS

New Publications Released During January 1989

- 4112.0 *Overseas Born Australians, 1988 (\$25.00)*
This publication presents a comprehensive statistical report focussing on Australia's population born overseas. Subjects covered include: demographic profile of migrants, their living arrangements, health, working life, education, income and housing. The style of the report is similar to that of the ABS's *Social Indicators, Australia, No. 4, 1984* (4101.0) i.e. with commentaries introducing data in each chapter and charts highlighting key data.
- 4117.0 *1988 Housing Survey, Housing Cost of Income Units, Australia, Preliminary (\$7.50)*
This publication provides statistics on nature of occupancy of dwellings and housing costs (rates, mortgage and rent payments) for income units, classified by income of income units, age of reference persons and other characteristics of income units and dwellings. Housing costs as a proportion of gross income are given for the various income unit types and the different occupancy categories. A limited range of data is also presented for States and Territories.
Tables of supporting data accompany the maps.
- 5348.0 *Foreign Control of Exports from Australia, 1985-86 (\$7.50)*
This publication provides statistics on Exports by country of destination, sections and divisions of the AECG, ASIC and States classified by control and country of control.
- 2201.1 *Census 86 - Children in New South Wales (\$8.50)*
This publication contains details of children aged under 15 years from New South Wales as reported at the 1986 Census. The tables show selected characteristics of children such as age, birthplace, local government area of usual residence and characteristics of children's families, parents, housing and living arrangements, and educational institution attendance. The tables are supported by a range of graphs and commentary of results.
- 4701.5 *Census 86 - Aboriginals in Western Australia, 30 June 1986 (\$11.00)*
This publication, which was compiled with significant contributions from the Aboriginal Affairs Planning Authority in Western Australia, presents a range of statistics on Western Australia's Aboriginal population. The information was compiled mainly from data collected at the 1986 Census of Population and Housing and includes chapters on population, language usage, families, education, labour force, income and housing.
- 2202.4 *Adelaide, A Social Atlas, June 1986 (\$25.00)*
The Atlas, prepared from 1986 Census of Population and Housing information, paints a detailed picture of the City's population in 43 multi-coloured maps. Topics depicted include growth areas, location of major migrant groups, unemployment distribution, the spread of sole-parent families, high income earners, low income families, home ownership, etc.
Tables of supporting data accompany the maps.
