EXPLANATORY NOTES

Introduction

This publication is issued each month as a supplement to the annual *Catalogue of Publications and Products, Australia* (1101.0) of the Australian Bureau of Statistics, which lists current ABS publications and gives brief descriptions (abstracts) of their contents. In addition, a *Publications Advice* (1105.0) is issued each Tuesday and Friday listing publications released on the day of issue and expected releases on the following five days (Canberra Office) or two days (State Offices).

2. Publishing News contains brief descriptions of the contents of new publications, describes changes in ABS publications and shows other information of interest to users of ABS publications.

Publication prices

3. A single price now applies to publications despatched by surface mail, both within Australia and overseas, and to counter sales. Airmail rates are available on request.

Mailing service

4. Clients who wish to receive free or priced publications on a regular basis may use the ABS Publications Subscription Service. Further details and order forms are available from any ABS office.

5. Clients who already use this service and who wish to amend their requirements should quote their account number when contacting ABS. The account number is shown at the top left hand corner of the address label used to despatch publications to clients.

6. Renewal notices are sent to all subscribers annually in respect of the subscription year commencing on 1 January. Payment for priced publications is required in advance and should accompany renewal notices returned to ABS.

Statistical information service

7. Each ABS office has an Information Service to assist clients. The service is designed to answer inquiries

from clients on available official statistics, including statistics not published for economic reasons. Unpublished statistics cover a variety of topics such as population, dwellings, building, imports, exports, shipping, etc., in the form of computer printout, microfiche, magnetic tape or specially prepared tables.

8. In cases where a considerable volume of data has to be specially extracted or where a regular statistical service is required, a charge will be made.

ABS PUBLISHING NEWS

New Publications Released During May 1990

- 1223.0 *Australian Standard Classification of Occupations (ASCO), Occupation Definitions — First Edition, 1989* (\$25.00)

This publication defines and describes the 1,079 units at the most detailed level of ASCO, the occupation level. A companion volume to the ASCO Statistical Classification, it is intended for those who require detailed occupational information. It is a necessary reference document for occupation level coding as defined in the *ASCO Coding System, Occupation Level* (1227.0).

- 4116.2 *Victorian Social Survey, May 1989, Preliminary* (\$3.50)

Presents social profile information on various groups such as young people (15-24 year olds), non-English speaking people, and single parents.

- 8637.3 *Intrastate Travel by Queensland Households, October 1989* (\$10.00)

Contains number and main purpose of intrastate trips of four nights or more taken by Queensland households during the 12 months ending 30 September 1989. Also includes details on the origin and main destination of trips, modes of transport used, accommodation used and activities engaged in during trips.
