MAIN FEATURES

New lending commitments during April 1986 were \$268.7 million, up \$38.2 million (16.6%) on March 1986.

Unsecured borrowings were \$6,709.5 million at the end of April 1986, an increase of \$144.1 million (2.2%) on March 1986.

Withdrawable share capital was \$10,660.5 million at the end of April 1986, a decrease of \$158.3 million (1.5%) on March 1986.

Total assets at the end of April 1986 were \$19,766.5 million.

EXPLANATORY NOTES

Introduction

This publication is compiled from statements furnished under the *Financial Corporations Act 1974*. It presents statistics on the financial operations, assets, selected liabilities and interest rates of those corporations registered under the Act which are categorised as building societies.

- Details of the scope and coverage of these statistics are provided in the July 1985 issue of this publication.
- The population for building societies may vary from month to month due to:
 - registration of new corporations;
 - change in category; and
 - deletion of corporations no longer registrable.

Particular care should therefore be taken in interpreting individual month-to-month movements.

Presentation

- Tables 1 to 3 continue the monthly series which commenced in July 1976, and these are now available on a State basis as from May 1984. Table 4 continues the series commenced in July 1978. Prior to June 1984 building societies with assets not exceeding \$5 million are

excluded from all series. Details of selected liabilities and assets (by quarter) for building societies with assets in Australia not exceeding \$5 million are contained in the publication *Financial Corporations Statistics, Australia* (5617.0), of which the final issue was for May 1984. Table 5 continues the monthly series on interest rates, by State, which commenced in June 1984.

Data items

- Data items are reported in accordance with the directions contained in the Schedule to the *Financial Corporations (Statistics) Regulations*. It should be noted that, unless otherwise specified in the directions, building societies have been requested to value their assets and liabilities on the basis used in their latest audited accounts.

Statistical period

- While the statistics are described as being for a statistical period (month/quarter) it should be noted that some building societies have accounting periods which do not correspond exactly to the statistical period and their figures are used without adjustment.

Comparability

- Because of differences in size and classification criteria, the statistics in this publication are not directly comparable with statistics for building societies in the publications *Housing Finance for Owner Occupation, Australia* (5609.0), and *Permanent Building Societies, Assets, Liabilities, Income and Expenditure, Australia* (5632.0).

Revisions

- This publication incorporates revisions made to statistics for previous periods.
