REGISTRATIONS OF NEW MOTOR VEHICLES, AUSTRALIA : OCTOBER 1967
PRELIMINARY STATEMENT

This preliminary statement of registrations of new motor vehicles will be followed by a supplementary statement showing registrations according to make of vehicle and at a later date by the monthly bulletin, which will give information in greater detail. All Commonwealth-owned vehicles are included other than those belonging to the defence services.

2. In these statistics, "registrations" means registrations processed by the motor vehicle registration authorities in the States and Territories during the period. Occasionally, in some States, registrations of new motor vehicles are not recorded in the statistics until some time after registration. Figures shown for Western Australia relate to registrations for the previous month in areas other than the Perth Statistical Division.

3. Original and seasonally adjusted registrations of new motor vehicles are shown in Table 1. In the seasonal adjustment, account has been taken not only of normal seasonal factors but additionally of "trading-day" effects (arising from the varying numbers of Sundays, Mondays, Tuesdays, etc. in the month) and the influence of Easter which may, in successive years, affect figures for different months. Each of the component series has been seasonally adjusted independently. Consequently, while the unadjusted components in the original series will add to the totals, the adjusted components may not add to the adjusted totals. Details of the methods used in seasonally adjusting these and other series are given in "Seasonally Adjusted Indicators, 1967" issued on 18 July 1967.
