PREFACE

In conjunction with the 1961-62 Census of Retail Establishments and Other Services a supplementary collection of Licensed Clubs was taken in respect of the year ended 30th June, 1962.

2. All clubs which were licensed by the appropriate licensing authority in each State or Territory to sell beer, wine and spirits were included in this collection. Details of trading reported by licensed clubs are shown in the following tables. Corresponding figures for 1956-57 are also included for purposes of comparison.

3. Some clubs leased catering rights to independent caterers who provided meals and refreshments and, in some cases, made sales of items such as confectionery and tobacco, cigars and cigarettes. Takings by independent caterers are not included in the tables in this Bulletin.

4. Most clubs reported sales of tobacco, cigars and cigarettes, but some which did not do so advised that sales of cigarettes were made through vending machines which were owned by independent organizations.

5. In tables 2 to 10 of this Bulletin the numbers shown for each item represent the total number of Census returns which recorded sales in that item. Some licensed clubs selling small quantities of Confectionery or Other Goods may not have shown these sales separately in their returns.

6. When final tabulations are completed the tables herein will be included in a series of detailed Bulletins of the Retail Census to be issued at a later date. The figures in the following tables may be subject to minor revision at that time.
