EXPORT PRICE INDEX

JUNE, 1964

This bulletin contains Export Price Index numbers on the reference base: Year 1959-60 = 100. This Export Price Index was first published for August, 1962. It replaced the previous Export Price Index which was published on the reference base: Average of 3 years ended June, 1939 = 100. A full description of the index and its relationship with the previous index is given in Statistical Bulletin S.B. 134 of 8th October, 1962.

2. The Export Price Index is a fixed-weights index. Its purpose is to provide comparisons monthly over a limited number of years of the level of export prices of the selected items, making no allowance for variations in quantities exported. The index numbers are thus measures of price change only.

3. The price series used in the index relate to specified standards for each commodity and in most cases are combinations of prices for a number of representative grades, types, etc. For some commodities price movements in the predominant market, or markets, are used, whilst for other commodities average realizations in all export markets are used. As nearly as possible, prices used are on the basis f.o.b. at the main Australian ports of export.

4. There are 29 items in the index. In recent years these 29 items have constituted approximately 83 per cent. of the total value of Australian exports. The weights are based on average annual values of exports during the 5 years 1956-57 to 1960-61.

5. The Export Price Index has been compiled for each month from July, 1959. Index numbers for each of the groups and All Groups are shown in Table 2 on page 2. The yearly index numbers are simple averages of the twelve monthly index numbers in each year.

6. Table 1 below shows for each index the percentage change of the index number for the month of June, 1964, from the preceding month (May, 1964) and from the corresponding month of the previous year (June, 1963). It also shows the percentage change of the average of the index numbers for the twelve months ended June, 1964, from the average of the index numbers for the twelve months ended June, 1963.
