Mark Green, currently Country Director of Caritas Australia's East Timor program, was most recently Coordinator of Refugee Advice and Casework Service (RACS) in New South Wales. He has also worked with the Refugee Council of Australia as Settlement Policy Officer and was a Jesuit for seventeen years. He has degrees in law, economics, theology and education.

Damian Grenfell is a researcher with the Globalism Research Centre and is part of the Timor-Leste Research Program at RMIT University. He is the author of various articles and reports relating to Timor-Leste, and is an editor for the forthcoming *Rethinking Insecurity, War and Violence: Beyond Savage Globalization?* (Routledge 2008).

Andrew McWilliam is a Fellow in Anthropology at the Research School of Pacific and Asian Studies, Australian National University. Fox) *Traditional Justice in Timor*, *The Asia Pacific Journal of Anthropology* (Special Issue) 8 (1), 2007.

Andrew Marriott is a PhD candidate at Deakin University, researching post-conflict justice sector reconstruction. Sara Niner is a Post-Doctoral Fellow at Monash University researching women, craft and development in East Timor. She edited *To Resist is to Win: the Autobiography of Xanana Gusmão with selected letters and speeches*, (Aurora Books, Melbourne, 2000). Her biography of Xanana Gusmão should be published this year by Australian Scholarly Publishing.

Yukako Sakabe is Programme Advisor at the Secretariat, International Peace Cooperation Headquarters, in the Japanese Cabinet Office. She has recently been involved in electoral monitoring, including the Timor-Leste National Elections in 2007. Her current research focuses on international assistance engagement and coordination in conflict-affected situations.

Dennis Shoesmith is Associate Professor of Politics at Charles Darwin University. He has worked as a consultant in Timor-Leste with the United Nations and
