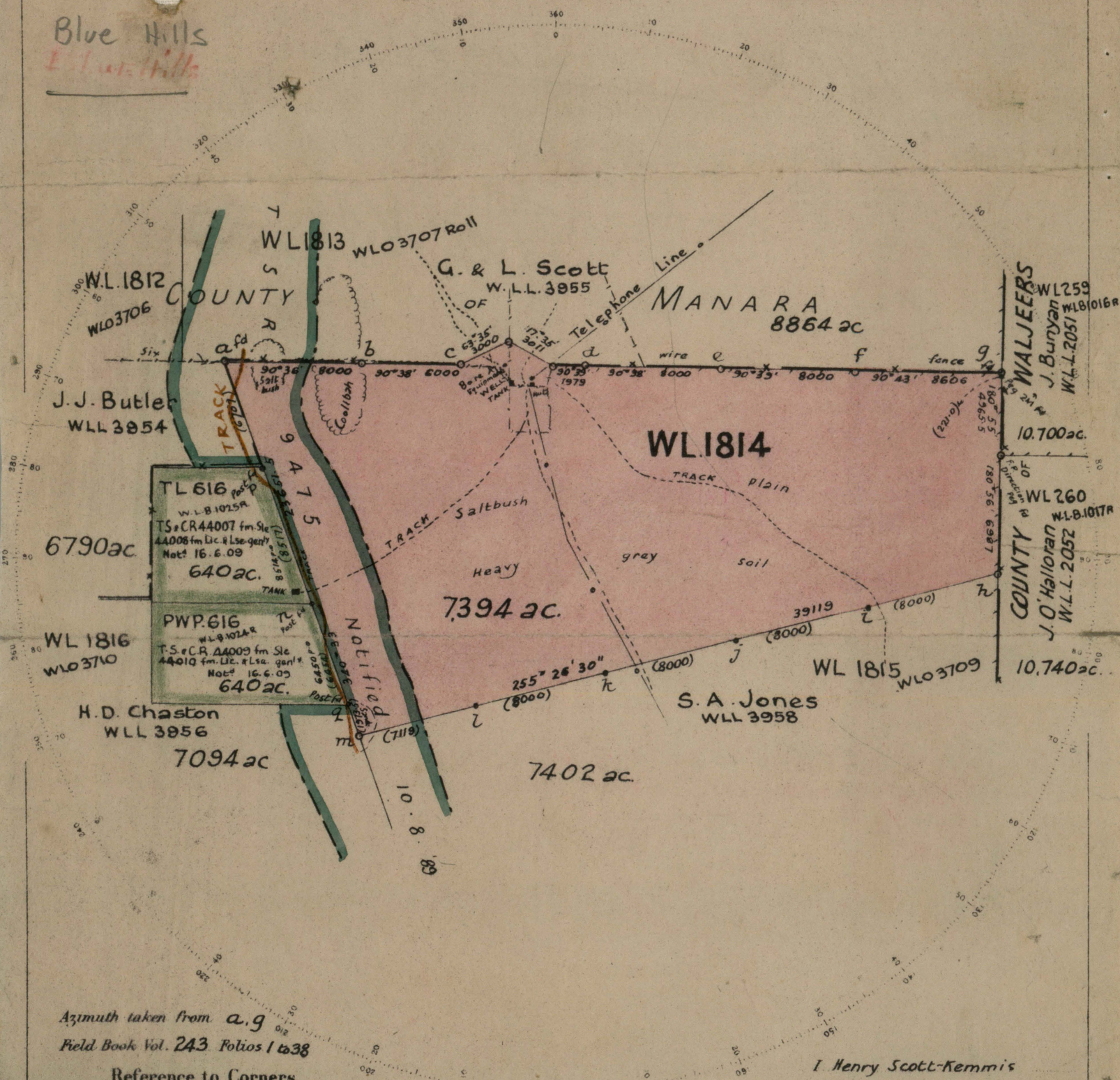
PLAN OF PORTION W.L. 1814.
